INDEPENDENT CONTRACTOR AGREEMENT

1. Engagement

The Company hereby engages the Contractor as an independent contractor to provide mobile detailing services ("Services") to clients scheduled through the Company's platform. Contractor accepts the engagement under the terms set forth below.

2. Independent Contractor Status

Contractor is engaged as an independent contractor and not as an employee, partner, or agent of the Company.

Contractor shall have no authority to bind or obligate the Company in any manner.

Contractor is solely responsible for determining how to perform the Services and using their own tools, equipment, and supplies.

3. Contractor Responsibilities

- Contractor agrees to provide high-quality detailing services according to professional standards.
- Contractor is solely responsible for maintaining all necessary licenses, permits, and, preferably, insurance (including general liability and auto insurance).
- While insurance is not required, Contractor is strongly encouraged to carry appropriate insurance to protect themselves and their clients.
- Contractor may provide proof of insurance to the Company, but it is optional.
- Contractor shall comply with all applicable laws and regulations.

 Contractor must upload clear "before and after" photos of the vehicle to the Company's platform or designated system immediately upon job completion as proof of service for quality assurance purposes. Failure to provide these photos may result in delayed payment or removal from the platform.

4. Scheduling & Acceptance

The Company facilitates client bookings and schedules Services.

Contractor will be notified of job assignments and must accept or decline within 2 hours of notification.

Failure to respond within 2 hours of same day appointment, 24 hours of next day appointment or repeated no-shows may result in removal from the Company's platform.

5. Payment

Contractor will be paid 60% of customer price per completed job.

Payments will be processed 24-48 hours after verification of job completion via agreed upon payment method.

No payment will be issued for incomplete or unsatisfactory services.

6. Liability and Indemnification

Contractor is solely responsible for all damages, losses, injuries, or claims arising from the performance of Services.

Contractor agrees to indemnify, defend, and hold harmless Detail Direct, LLC, its affiliates, officers, and employees from any and all claims, liabilities, damages, or expenses (including attorneys' fees) arising from Contractor's acts or omissions.

The Company shall not be liable for any damages or losses caused by Contractor.

7. Insurance

While insurance coverage is preferred to protect both Contractor and clients, it is not a requirement for participation.

Contractor who carries insurance is encouraged to provide proof to the Company but may decline without penalty.

Contractor understands that operating without insurance means they assume full risk for any damages, losses, or liabilities incurred during service delivery.

8. Confidentiality

Contractor agrees to keep all client and Company information confidential and not use such information for any purpose outside of performing the Services.

9. Use of Branding

Contractor shall not use the Company's name, logo, or branding for any purpose other than performing contracted services without prior written consent.

10. Termination

Either party may terminate this Agreement at any time with written notice.

The Company may terminate immediately for breach of contract, unprofessional conduct, or repeated failure to meet scheduling commitments.

11. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the state of Texas.
